The Forty-Fourth Annual Convention of the Episcopal Diocese of North Dakota October 18, 2014 Bismarck, North Dakota

The Forty-Fourth Annual Convention of the Episcopal Diocese of North Dakota was called to order with opening prayers led by the Rt. Rev. Michael Smith, Bishop of North Dakota, at 8:00 a.m. on Saturday, October 18, 2014, at the Radisson Hotel in Bismarck.

The Bishop announced the following appointments for convention:

The Bishop will announce the nominations.

The Bishop welcomed the individuals from Colorado and Texas.

The Bishop called on Deacon Beth Lipp (St. George's, Bismarck), chair of credentials committee, for a report. Lipp announced that 30 of 37 clergy and 73 of 105 lay delegates have registered making a quorum. Eight guests were also in attendance.

The Bishop announced the nomination of Sandra Myers (All Saints', Minot) for secretary of convention; there were no other nominations. Motion was made, seconded and passed to close nominations and instruct the secretary to cast a unanimous ballot for Myers.

The Bishop reported that Charlotte Peterson (St. Paul's, Grand Forks) had been nominated for Treasurer of the Diocese. There were no additional nominations. A motion was made, seconded and passed to close nominations and instruct the secretary to cast a unanimous ballot for Peterson.

The Bishop asked for a motion to approve the minutes from the 2013 Annual Convention. Motion was made, seconded and passed to approve the minutes.

The Bishop announced the nominations of the Rev. Mary Johnson (All Saints', Minot) and the Rev. James Shannon (St. Paul's, Grand Forks) for one three-year clergy term on Standing Committee. The Bishop asked if there were nominations from the floor. There were no additional nominations.

The Bishop announced the nominations of Dwight Koch (St. James, Cannon Ball) and Don Henderson (St Paul's, Grand Forks) for one three-year lay term on Standing Committee. There were no additional nominations.

The Bishop asked delegates to cast their ballots for the clergy and lay persons for the positions on the Standing Committee. Delegates cast their ballots and tellers collected them.

The Bishop announced the nominations for two three-year terms for the Episcopal Foundation for Ministry in Higher Education: Yvonne Fox (St. Paul's, White Shield) and Carol DeWall (St George's, Bismarck). Motion was made, seconded and passed to close nominations and instruct the Secretary to cast a unanimous ballot for Fox and DeWall.

The Bishop asked the secretary of convention to read the North Dakota and Texas Partnership Resolution.

Whereas, the Diocese of North Dakota has partnered with other Diocese of the Anglican Communion in the past and has been richly blessed by these relationships; and

Whereas, God has given the Church in our two Dioceses a variety of complementary gifts for the glory of the Gospel of Jesus Christ, and it is an honor for Christians to assist one another in God's work; and

Whereas, both Dioceses share a missional vision including expansion through church planting, ministry to the vulnerable, a deep respect for the variety of cultural heritages of our people, an openness to learn from one another, a heart for joining with one another in Christian testimony through service, and a hope to develop a mutually transformative relationship between our people;

Therefore, be it resolved that the Diocese of North Dakota adopt a Covenant of Companion Relationship between the Episcopal Diocese of Texas and the Episcopal Diocese of North Dakota.

The Bishop asked the convention delegates for questions. The North Dakota & Texas Partnership Resolution passed by voice vote.

The Rt. Rev. Carol Gallagher was presented a cope (blanket) and Rev. Canon Mark Stevenson will be given a North Dakota Diocese lapel pin.

The Rt. Rev. Dena Harrison, Bishop Suffrigan of Texas was presented a cope (blanket) and Rev. Bertie Pearson and Rev. Eric Hungerford were presented with a North Dakota Diocese lapel pin.

Bishop called on the Rev. James Shannon (St. Paul's, Grand Forks), Dispatch of Business, who called on the Rev. Bart Davis (Grace Church, Jamestown). Davis reported that the Diocesan Council approved the Pooled Investment Fund and that it would be available to congregations after the first of the year. The Pooled Investment Fund will give congregations more choices on where to invest their funds. It is an opportunity to be part of a larger pool of funds.

The Rev. Canon John Floberg (Standing Rock congregations) reported how the star quilt silent auction will work. He also reported on the Episcopal Relief & Development work in the State.

Leo Wilking (St. Stephen's, Fargo) was called on to report about the Episcopal Foundation. Grants will be given out in 2015 that will total \$5,000 to \$6,000 up to \$1,000 for each grant. Grants will be available for youth ministry, evangelism, campus ministry, mission and ministry outside the Diocese, and Sudanese ministry. Grant applications will be due in December 2014, reviewed in January 2015 and awarded in March 2015 and the funds will need to be used by December 2015.

Shannon called on Charlotte Robbins (Gethsemane Cathedral, Fargo), Episcopal Relief & Development. Robbins reported that the 2015 MDG focus will be on South Sudan where the work supported by ER&D addresses several of the Millennium Development Goals. Each congregation is asked to undertake some fund raising efforts in the coming year to generate contributions for work in South Sudan. Ericka Morlan (Gethsemane Cathedral, Fargo) will be taking over the Diocesan ER&D work. The Bishop thanked Charlotte for her many years of work for our Diocese.

Pat Fearing and Odella Henley (All Saints', Valley City), co-chairs for UTO, were called on to give their annual report. Fearing pointed out the UTO report will be made available. \$3,420.06 was given to the national UTO in 2013. Fearing thanked all the UTO representatives in each congregation. In closing Pat explained a new weight reduction process. Weight reduction can be accomplished by giving the coin out of your pocket to UTO. The UTO collection boxes were on each table.

The Bishop referred to the sheet in packets appointing various committees of the diocese and asked for ratification of the disciplinary board which has been approved by the Standing Committee. By voice vote delegates ratified the appointments to the disciplinary board.

The Bishop announced the results of the election for the clergy and lay positions on Standing Committee: Clergy position (3 year term): the Rev James Shannon (St. Paul's, Grand Forks)

Lay order (3 year term): Don Henderson (St. Paul's, Grand Forks)

Shannon announced rooms for the regional meetings to be held at 1 o'clock, following lunch. Christie Iverson (St. George's, Bismarck) chairs the West meeting and the Rev. Barb Olson (St. John's, Moorhead) the East meeting.

Rueben Panchol (St George's, Bismarck) asked us to put South Sudan in our hearts through prayer.

Convention business adjourned temporarily in order to travel to St. George's for the convention Eucharist.

Following the convention Eucharist, lunch, and the regional meetings, the convention reconvened for the afternoon's business.

It was announced that the elections for Diocesan Council from the western regional meeting were the Rev. Erin Richards (All Saints', Minot) and Robert Fox (St. Paul's, White Shield) and from the eastern region the Rev. Terry Overbo (Gethsemane Cathedral, Fargo) and Linda Hokana (Sts. Mary and Mark, Oaks) were elected.

The Bishop called on Lipp for a credentials report; she reported that 31 of 37 clergy and 75 of 105 lay delegates are in attendance making a quorum.

Bishop called on Charlotte Peterson (St. Paul's, Grand Forks), treasurer for the diocese, to present the 2015 budget. Peterson walked the delegates through the proposed budget and explained variations in income and/or expenditures from the 2014 budget. Investment draw was less than budget. Oil income increased in 2014. The royalty receipts have been put into the Bakken fund. \$22,000 is budgeted for 2015 – that is 70% of the amount expected. Bishop and Floberg added information about paying the National Church Program share. The national church is recognizing that the ND Diocese is increasing its percentage even though we have financial challenges. Salaries increased by cost of living with the exception of Leisha Woltjer (Diocesan Administrator), who's was increased more than cost of living. Leisha remains the only administrative person in the Diocese office. Leo Wilking urged the finance committee to keep working to drop the investment draw to 5% - a number set as policy several years ago. A motion to approve the budget was moved and seconded as presented, and all were in favor.

John Baird (St. Stephen's, Fargo) gave a report on his participation in the medical Guatemala trip. We partnered with the Diocese of Guatemala. St Peter's, Williston raised money for the trip last year by having a rummage sale. Most congregations in ND have contributed money toward this trip. They need about 20 individuals – mostly medical. Financial assistance is always welcome.

The Rev. Elsie Magnus (St. Peter's, Walhalla) gave information on how to find the newest scholarship forms.

The Bishop asked the Rev. Jamie Parsley (St. Stephen's, Fargo) to present the courtesy resolutions – they are as follows:

Whereas, our Diocesan Council has once again helped to facilitate a one-day, centrally-located Diocesan Convention in Bismarck; and

Whereas, this Convention would not be possible without significant assistance from the clergy, staff, and membership of St. George's Episcopal Church; and

Whereas, the planning and participation by these committed Christians has again resulted in an excellent Convention and worship experience;

Therefore, Be It Resolved by this 44th Convention of the Episcopal Diocese of North Dakota, that we express our thankfulness and gratitude to all of the members of the Diocesan Council, Canon Zanne Ness, and all of the committees and members from St. George's for their leadership and coordination efforts which have resulted in another pleasant convention experience for all of us.

Whereas, Father Mike Horn, served faithfully as Rector of St. George's for 16 years, and

Whereas, his consistent leadership as host for the Eucharist of this Convention for several years is much appreciated;

Therefore, Be It Resolved by this 44th Convention of the Episcopal Diocese of North Dakota, that we are grateful for all the many ways Father Mike Horn served this Diocese, and we send our best wishes and prayers for him in his retirement.

Be It Further Resolved that the Secretary of the Convention provide a copy of this resolution to Father Mike Horn to document our appreciation.

Whereas, Bishop Dena Harrison, suffragan bishop of Texas, and the Reverend Eric Hungerford and the Reverend Bertie Pearson, traveled all the way from Texas to Bismarck to represent the Diocese of Texas, and

Whereas, their presence among us and example of church growth and vitality was appreciated and met with gratitude, and

Whereas, we look forward to continued shared ministry between our two dioceses;

Therefore, Be It Resolved by this 44th Convention of the Episcopal Diocese of North Dakota that we are grateful and appreciative to Bishop Harrison, to the Reverend Eric Hungerford and the Reverend Bertie Pearson for their travel to and participation in this convention, as well as their commitment for future shared ministry; and

Be It Further Resolved that the Secretary of the Convention provide a copy of this resolution to Bishop Harrison, the Reverend Eric Hungerford, the Reverend Bertie Pearson and Larry Harrison to document our appreciation.

Whereas, we are grateful to Canon Mark Stevenson for his words of wisdom to us on mission; Therefore, Be It Resolved by this 44th Convention of the Episcopal Diocese of North Dakota that we express deep gratitude to Canon Mark Stevenson for his presence with us at this convention.

Whereas, we in the Episcopal Diocese of North Dakota have been grateful for the ministry of Bishop Carol Gallagher to us, and

Whereas, her dedication, care and prayers as Assistant Bishop of the Episcopal Diocese of North Dakota is much appreciated by us all;

Therefore, Be It Resolved by this 44th Convention of the Episcopal Diocese of North Dakota that we are grateful for Bishop Carol Gallagher and her ministry with us; and we wish her best wishes and our heartfelt prayers as she serves as the Assistant Bishop of Montana and Bishop Missioner for the Bishop's Native Collaborative.

Be It Further Resolved that the Secretary of the Convention provide a copy of this resolution to Bishop Carol Gallagher to document our appreciation.

Whereas, Sandy Holbrook, long-time Secretary of this Convention, is unable to serve in that capacity this year, and

Whereas, her loyalty to and consistent and dedicated work in multiple ways for the Diocese is much appreciated;

Therefore, Be It Resolved by this 44th Convention of the Episcopal Diocese of North Dakota, that we are grateful for all the many ways Sandy Holbrook has served the Diocese of North Dakota, most especially as Secretary to this Convention for over a quarter of a century,

Be It Further Resolved that the Secretary of the Convention provide a copy of this resolution to Sandy Holbrook to document our appreciation.

Be It Resolved by this 44th Convention of the Episcopal Diocese of North Dakota that we are appreciative of the efforts of Leisha Woltjer, as our diocesan staff person, and those she has asked to help, for all of their hard work and concentrated effort to make this a successful convention from registration through the closing gavel.

Be It Resolved by this 44th Convention of the Episcopal Diocese of North Dakota that we are thankful and appreciative for all we learned for our hearts, souls and spirituality from the displays provided at this convention.

Be It Resolved by this 44th Convention of the Episcopal Diocese of North Dakota that we are thankful for the past service to the diocese by retiring members of the Diocesan Council and the Standing Committee.

Whereas, we, in the Episcopal Diocese of North Dakota, have among us new Americans fleeing war and strife in Southern Sudan; and

Whereas, we are aware that, when any part of the Body of Christ suffers, we all suffer;

Therefore, Be It Resolved by this 44th Convention of the Episcopal Diocese of North Dakota that we recommit ourselves to intercessory prayer and support for peace in South Sudan.

Whereas we, as a faithful community of Christians who hope and believe in the Communion of Saints, and recognize ourselves as part of the larger Church; and

Whereas some of those who have labored alongside us in the ministries we have been called to do here in the Episcopal Diocese of North Dakota have been called by our Lord and Savior to rest from their labors; and

Whereas their presence with us today and always is missed, but their example and the fruits of their labor are appreciated by us;

Therefore, Be It Resolved by the 44th Convention of the Episcopal Diocese of North Dakota that we are forever grateful for the lives and ministries of the departed servants of God, Deacon Barb Lander, Deacon Terry Star and Father Kendall Johnson, who now dwell in that place of light and joy, where sorrow and pain are no more.

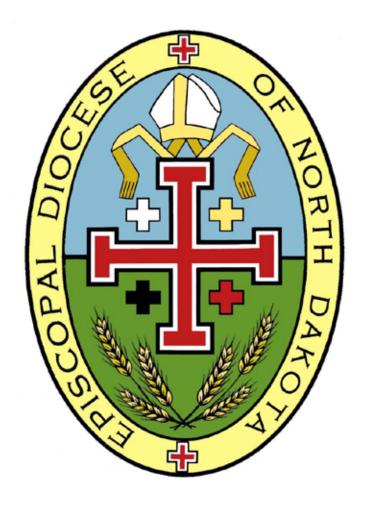
The Bishop announced that next year's convention will be held at the Radisson in Bismarck on October 16-17, 2015.

NOTES & EXPLANATIONS FOR THE 2015 BUDGET

Chairs of committees appointed by Bishop Michael at the last Diocesan Convention were asked to submit year 2015 budget requests. Amounts as requested were inserted into the 2015 working budget. The proposed budget represents recommendations by the Finance Committee as approved by Diocesan Council. Other budget figures are a result of Diocesan policy, input from Bishop Smith, 2013 actual and 2014 estimated expenditures, and projected cost figures gathered from other sources.

A few items to note:

NDCIM: The NDCIM budget is funded by the General Convention grant for Native American Ministry and a grant for a Tribal Campus Chaplain. The total of these grants for 2015 is \$192,600. In order to continue receiving these grants, the Diocese must ensure the grant funds are spent on Native American Ministry. NDCIM expenses must be equal to or greater than the funds received.

Investment Fund Transfers: We have drawn only \$50,000 of the budgeted amount from our investments so far this year. This is because our cash flow has remained steady due to the Royalty Income, Bakken Ministry Income, the General Convention Grant, and timely Our Fair Share payments. We do expect to draw at least another \$50,000 by the end of the year.

Bakken Ministry Funds: The Diocese owns several mineral rights in the Bakken. At the beginning of 2014, the Diocesan Council created the Bakken Ministry reserve fund. Monies in this fund are a result of bonus payments from mineral leases and royalty income received above the budgeted amount. The Diocesan Council has ear-marked this money to be used for ministry in the oil fields. Specifically, to assist St. John's, Dickinson in their new partnership with a Lutheran pastor and to pay utilities for the rectory to be purchased in Williston for a new priest at St. Peter's (yet to be called).

Following are notes/comments to provide additional information about some of the proposed budget items:

INCOME

<u>Line 2 - Our Fair Share</u>: It is recommended that OFS percent remain the same in 2015 as in previous years at 20%. Calculation for OFS is as follows:

Actual Prior Year End (2013) / Prior Year Percent (2013 was 20%) X Budget Percent (20%).
 \$234,053 / 20% = \$1,170,265 X 20% = \$234,053

<u>Line 3 - Investment Fund Transfers</u>: The year-end balances are \$2,556,403.77, \$2,558,987.98 and \$2,788,590.75 respectively for an average of \$2,633,799.43. For 2014, we have been drawing 7%. The proposed budget shows decreasing the draw from 7% to 6.75%. Below are income figures per percentage for reference:

<u>Line 5 - General Convention Grant:</u> The Diocese will receive \$181,000 per year for the triennium (2013-2015) for Native American Ministry. This was passed at General Convention in Indianapolis in 2012.

Line 7 - Bishop's Additional Employment: None expected.

<u>Line 8 - From Designated Funds:</u> The proposed budget shows 4,000. To come from Bakken Ministry reserve for Episcopate Automobile Purchase (Line 60).

<u>Line 10 - Sheaf Donations:</u> Based on prior years actual donations.

Line 11 - Youth Program Income: None budgeted.

<u>Line 12 - Convention Income:</u> Diocesan Convention registrations, based on actual past conventions.

<u>Line 13 - Royalty Income:</u> Income from our producing wells in the Bakken. With input from Bart Davis, proposed budget shows \$22,000.

<u>Line 14 – Tribal Campus Ministry Grant:</u> The Diocese will receive a grant for \$11,600 for 2 years (2015-2016) for Native American Campus Ministry

EXPENDITURES

<u>Line 20 - National Church Program:</u> The Episcopal Church funding formula asks dioceses to pay 19% of net operating income earned two years prior to the budget year, with the first \$120,000 and the \$181,000 General Convention Grant exempted. The Episcopal Church finance office requests dioceses that are not able to fulfill the 19% assessment increase giving by 1% each year. Our General Convention grant increased beginning in 2013. Thus, because we exclude the General Convention grant from the formula, our net operating income decreased.

The proposed budget shows an increase from \$44,000 to \$45,511, representing a 17% giving level. (3.75% increase)

<u>Line 21 - General Convention Deputies:</u> The next General Convention will be held in Salt Lake City, UT, in 2015. Cost of the 2012 General Convention was approximately \$24,000 to send 4 clergy delegates, 4 lay delegates, plus bishop. To ensure there is enough in the reserve to send 4 & 4 we need to budget \$8,000 each year for 3 years (2013-2015). (The bishop's GC expenses will come out of his travel expense.)

Breakdown of the estimated GC Costs per person:

Hotel: \$1,285 (10 nights, 1 room)

Airfare: \$500 per person (average based on today's prices)

Registration: \$495 per person

Per Diem: \$610 (\$61 per day (10 days), per person-IRS per diem rate for 2014)

Total \$2,890

<u>Line 22 - Province VI Assessment:</u> An assessment that is paid to Province VI quarterly.

<u>Line 23 - Province VI Synod Delegates:</u> Provincial Synod will now take place every 3 years, the same as General Convention. To make sure there is enough to send 4 delegates every 3 years, there should be \$4,000 in the reserve fund by 2015. By the end of 2014, there will be just over \$4,000. Suggest budgeting \$500 for 2015.

<u>Line 24 - Lambeth Conference:</u> Budgeted amount goes into a reserve fund to pay the expenses of the bishop's and spouse's attendance at Lambeth Conference, which meets every ten years.

<u>Line 25 - ND Conference of Churches:</u> The Diocese supports the work of the North Dakota Conference of Churches with an annual pledge.

<u>Lines 28-46 - Programs & Outreach:</u> The program and outreach line items reflect mostly what was requested by the committees with a few adjustments made.

- Decreased Line 34 (Continuing Ed., Clergy/School for Ministry) to \$3,850. Attendees of the Clergy/Minister's Conferences will be asked to pay a fee to help offset expenses. Fees for attendees from Native Congregations will be charged to the Native American Leadership Training reserve fund.
- Decreased Line 38 (Camp Gabriel) to \$3,000.
- Line 42 (East African Mission) remains the same as 2014.
- Lines 44-45 (ERD Network/MDG Advocacy) have been combined at the request of Sandy Holbrook and Charlotte Robbins, joint chairs.
- Line 46 (Refugee Resettlement) remains the same as 2014.

<u>Lines 49-163 - Salary & Benefits:</u> Salaries and stipends are based on step (.25%) plus 2% Cost of Living Adjustment, with the exception of the Administrator. As of May 2014, the Consumer Price Index shows COLA at 2.1%.

Family medical/dental/vision insurance and a \$25,000 term life insurance policy are provided for the bishop, clergy employed by the diocese, and diocesan office staff. The Episcopal Church Medical Trust premiums reflect a 7% increase over 2014. Life insurance premiums remain the same. The Employee Assistance Program (EAP) is a confidential counseling service offered to employees (including non-stipendiary clergy).

<u>Lines 58-64 - Episcopate Program Expenses:</u> The proposed budgeted amounts remain the same as in 2014. Note: Any remainder from Line 67 (Travel Expense) will be transferred to Diocesan Car Reserve at end of year.

<u>Line 157 – Receptionist:</u> Rebecca Lein (Gethsemane Cathedral Coordinator/Diocesan Receptionist) resigned in January 2014. The position has been eliminated.

The proposed budget shows the following changes to the Salary & Benefit section:

- Line 50 (Episcopate Continuing Ed.) remains the same as 2014. \$2,500 can be made available from Native American Leadership Training reserve, if needed.
- Increased Line 60 (Automobile Purchase) to \$4,000 (see explanation for Line 8 above).
- Increased Line 140 (Administrator Salary) to \$42,872. This represents a \$5,000 increase from 2014.
- Decreased Line 153 (Continuing Ed., Admin) to \$500.
- Decreased Line 154 (Travel Expense, Admin) to \$0.

<u>Lines 165-175 - Other Congregational Support</u>

<u>Line 166 - Indian Property Repairs:</u> Part of the NDCIM budget.

<u>Line 167 - CM House Insurance/Repairs:</u> Annual Insurance premium of \$2300 and \$700 for repairs to the rectory in Bismarck. 74% to come from NDCIM budget.

<u>Lines 168-174 - Indian Property Insurance:</u> Figures in the 2015 proposed budget are actual premiums provided by Church Insurance. Part of the NDCIM budget.

Note from Church Insurance: "As you know, it is our mission to assist the Episcopal Church in a financially responsible way while providing the broadest coverage available. With this in mind, we have made the following coverage adjustments which will become effective upon renewal of your policy.

- Coverage for Directors & Officers including Employment Practices Liability is included at a limit of \$1,000,000.
- The Episcopal Entities Doctrinal Disputes Exclusion has been added to the Commercial General Liability section of coverage.
- Coinsurance will be changed to 100% coinsurance waived. Building and contents values will be increased by 17% to reflect a 2% increase in construction costs and an additional 15% for demolition and debris removal costs."

Lines 177-212 - Administrative Expenses

<u>Lines 178-184 - NDCIM General Expenses:</u> Part of the NDCIM budget. Per recommendation of NDCIM, Lines 179-183 were combined and the proposed budget shows \$5,000. This includes Convention fees for NDCIM congregations.

Lines 186-191 - Administrative Meetings:

Line 187 - Convention: The proposed budget amount is the actual cost of last year's convention.

<u>Line 188 - Diocesan Council/Standing Committee:</u> The proposed budget amount is based on the cost of Diocesan Council/Standing Committee meetings in 2013 and so far in 2014. Costs include hotel, mileage and meals for the meetings. Proposed budget shows an increase to \$11,000.

<u>Line 189 - Other Administrative Meetings:</u> The proposed budget amount is based on actual spending in 2013 and so far in 2014 which includes Finance Committee meetings.

<u>Lines 192-208 - Office Expenses, Insurance and Misc:</u> Includes office supplies, postage, printing, internet, copy machine, etc. Proposed budget amounts are based on actual 2013 and so far in 2014.

<u>Lines 202-204 – Insurance</u>: Figures in the 2015 proposed budget are actual amounts of premiums provided by Church Insurance. Combined Office Insurance and Office Umbrella into one line item. Note from Church Insurance (see Line 168-174 above).

2013 FINANCIAL HIGHLIGHTS

2013 Income & Expense vs. Budget: We ended the year with a net loss of \$3,560 versus the budgeted net income of \$6,379. Considering, the Bishop's Additional Employment income was \$36,640 less than expected, this is a fair result. Bishop Michael's time as 2/3 time Dean ended in July 2013. The net loss was a result of not taking the full budgeted amount for Investment Fund Transfers. It was felt that since the net loss does not affect the audit and the cash was not needed at the time, the money should be left in the investments to grow. Other items to note include:

П	Income:	Overall income	was \$38.762	under budget

- Our Fair Share: The Diocese received \$234,053 in Our Fair Share payments, which was \$9,034 over the budgeted amount.
- Investment Fund Transfers: The budgeted amount of Investment Fund Transfers for 2013 was \$130,047 (5%). The actual amount taken was \$100,000 (3.85%). Cash flow remained steady through-out the year, so it was not necessary to take the cash from investments.
- o **General Convention Grant**: General convention grant came in as budgeted.
- Other Income:
 - Royalty Income We received \$23,150 in royalty payments for our mineral leases which have producing wells.
 - Sheaf Donations a few small donations and one large donation of \$1000 was received.
 - Youth Program Income Although no income was budgeted, a small amount was received for two events.
 - Convention Income more attendees than last year.
- ☐ **Expenses:** Overall expenses were \$28,823 under budget.
 - Extra-Diocesan: Amounts were as budgeted. These were either set amounts or went into reserve funds, where they are expended.
 - **Program:** This section was under budget by \$3,939. A few committees and/or programs did not spend the full amount budgeted.
 - Salary & Benefits: This section was \$23,610 under budget mainly due to the change in the Communications Coordinator, several travel expenses not fully utilized, and Diocesan Office Staff continuing education not being used.
 - Congregational support: This section was over budget by \$3,055 due to unexpected repairs to the Canon Missioner's house in Bismarck and a few insurance premiums higher than budgeted.
 - o **Administrative Expenses:** This section was under budget by \$4,329.
- ☐ Bottom line, as stated earlier, was a net loss of \$3,560.

Investments: The market value of our investment account as of December 31, 2013, was \$2,788,590.75. As a comparison, the market value at year end over the past ten years has been:

2014 FINANCIAL HIGHLIGHTS TO DATE (September 30, 2014)

2014 Income & Expense

- *Income:* As of September 30, the Diocese has received \$126,440 in Our Fair Share, which is 57% of budget. This amount is down 2% from last year at this time. Our cash flow has remained steady due to the Royalty Income, Bakken Ministry Income, the General Convention Grant, and timely Our Fair Share payments. Due to these reasons, we have transferred only 27.5% (\$50,000) of our 2014 budgeted amount from investments.
- Expenses: Most expense items are tracking at the levels they should for this time of year. A few items to note:
 - Canon Missioner East Pension (Line 95) is at 98% of budget for the year. We will be receiving a refund of \$700 for Kevin Goodrich's 3rd quarter pension.
 - Canon Missioner East Health/Life Insurance (Line 97) is already over budget for the year. This is due to the staff change from Kevin Goodrich to Christian Senyoni. Kevin was covered for single health insurance and Christian is covered for family health insurance.
 - Indian Property Repairs (Line 170) is at 99% of budget for the year. This is due to payments made to contractors repairing the roof at St. Paul's, White Shield.
- Bottom Line: The bottom line of -\$112,438 is significantly higher than last year at this time (-\$66,451). This can be attributed to only taking 27.5% of our budgeted investment transfers.

Liabilities & Net Assets (Balance Sheet)

- **Operating Fund:** The operating fund shows the various unrestricted designated and temporarily restricted fund balances. Some of these have no activity through the year and others have a number of transactions in the funds.
- Trust & Endowment Fund: Our investment balance as of September 30, 2014 is \$2,814,871. We owe \$90,293 (as of September 30) on the Canon Missioner's house in Bismarck and there are 2 congregations making loan payments to the diocese; St. Peter's, Walhalla, and Advent, Devils Lake.

We anticipate to draw less than the 7% reflected on the 2014 budget. This means are draw will be less than the return and we will not be touching the principle.

Bishop's Sermon to the Forty-fouth Annual Convention of the Episcopal Diocese of North Dakota October 18, 2014

Recently, I had the good fortune to lead worship at the Church of St. Francis in Canyon Lake, Texas. At the top of their Sunday bulletin was printed: "St. Francis Domestic and Foreign Missionary Society," and, parenthetically, as to explain to those unfamiliar with the initials DFMS, was noted "The Episcopal Church."

"The Domestic and Foreign Missionary Society of the Protestant Episcopal Church in the United States of America" is how the Episcopal Church is officially incorporated. It is oftentimes shortened to the DFMS, and in recent years the national church has used the term, the "missionary society" as a marketing tool. But I had never seen or heard of a congregation use those words to describe their parish. It got me to thinking...

First of all, the word "missionary" is problematic for well known, historic abuses of the past in Native American communities. This means a significant number of members of this Diocese would not be able to affirm such terminology. However, what if we used the term "mission society' instead of "missionary society," and "mission worker" rather than "missionary"? At least for today, then, I'd like to address the "Mission Society of the Episcopal Diocese of North Dakota."

What has the Mission Society been up to since we were last together a year ago?

- Mission workers Christian Senyoni and Terry Overbo organized and gathered youth from Fort Totten, Cannon Ball, Jamestown, and the Cathedral for an event in Fargo.
- We welcomed a mission team from Trinity Church of The Woodlands, Texas to Fort Totten.
- We continued our support of the Millennium Development Goals through Episcopal Relief & Development.
- We grew our pool of "mission workers" for stewardship through the Episcopal Network for Stewardship.
- We sent mission worker, Danny Whitehead, to develop ministry in a First Nations parish in British Columbia.
- We consecrated a beautiful and inspiring building for worship at Cannon Ball, a space which also houses, on average, fifty-five youth every Wednesday evening for Young Life.
- We continued construction on a worship space and mission headquarters for the community at Dunseith.
- We partnered with the Iona School for Ministry of the Diocese of Texas, Nashotah House Seminary, the Bishops' Native Collaborative, and Sitting Bull College to develop mission training programs for our mission society and beyond.
- We ordained mission workers, Erin Richards and Paul Zaharia, as deacons in Minot.
- We sent mission worker, John Baird, with a medical team to serve people in Guatemala.
- We grieved with the Sudanese people of St. John's in Moorhead over the continuing civil war in their homeland, and are pledging to stand with them by supporting Episcopal Relief and Development efforts in South Sudan.

- We began a new mission partnership with the Diocese of Texas, which we celebrate today.
- We welcomed worker, Heather Baggett, to the mission field of St. Alexius' Hospital in Bismarck as a chaplain.
- We recruited new workers to the mission field by offering a retreat entitled, "Exploring a Life with God: Taking the First Steps in an Intentional Spirit Journey."
- We mourned together as we said goodbye to our beloved deacon, Terry Star.
- We offered a retreat for preachers, led by Patti Hale, a mission worker from the Diocese of Oregon.
- We celebrated the life of mission worker, Kendall Johnson, here at St. George's.
- We sent worker, Kevin Goodrich, on a preaching and teaching mission to Florida and beyond.
- We assisted in forming a new mission partnership between St. John's in Dickinson and two ELCA congregations in Richardton and Dickinson. We welcome Pastor Ellery Dykeman and his wife, Anna, to collaborate with this mission society.
- We are in the process of working with St. Peter's, Williston in providing housing and searching for a leader to organize mission to the incredible Bakken oil boom and the thousands of people who are moving to our part of the world.
- We engaged in mission work by providing scholarships to student in East Africa.
- We continued to give thanks and support for the United Thank Offering and the mission work U.T.O has made possible here and beyond.

You get the picture.

At the beginning of this month, the Task Force for Reimagining the Episcopal Church invited participation in a gathering at Washington National Cathedral. I viewed the live stream of their presentations and was especially struck by the words of Bishop Michael Curry of North Carolina who stated that what this church needed most was "revival."

"Revival" is not a word often associated with the Episcopal Church, but we see it in today's Gospel where Jesus, "filled with the power of the Spirit, returned to Galilee" (Luke 4:14). We, too, need to be revived, to be filled with the power of the Holy Spirit. Why?

Because the mission work we are called to do is next to impossible without being energized by the Holy Spirit. The Five Marks of Mission remind us that

- We are sent "to proclaim the Good News of the Kingdom."
- We are sent "to teach, baptize and nurture new believers."
- We are sent "to respond to human need by loving service."
- We are sent "to seek to transform unjust structures of society, to challenge violence of every kind and to pursue peace and reconciliation."
- We are sent "to strive to safeguard the integrity of creation and sustain and renew the life of the earth."

Those are tall orders indeed. Fortunately, we are not called to do these things alone. Let us pray.

Come Holy Spirit: Come as the wind and cleanse; Come as the fire and burn; Convict—convert—consecrate our lives, to our great good and your greater glory. May we, with Jesus, be able to say "the Spirit of the Lord is upon us, because he has anointed us to bring good news to the poor. He has sent us to proclaim release to the captives and recovery of sight to the blind, to let the oppressed go free, to proclaim the year of the Lord's favor."

And all God's people said: Amen.
