Other tribes such as the Michif Piyii, Yanktonai, Anishinabewaki and divisions of Očhéthi Šakówin later occupied this land. Devils Lake, the English name for these waters, is a deliberate and oppressive mistranslation of its original name that can be translated spirit or sacred. Many tribes have sojourned to these waters, as they are believed to be sacred healing water as their true name suggests.
