  - Line 2020: General Convention Reserve Fund move funds into the reserve fund for next year's convention from available surplus at the end of the year up to an additional \$10,000
  - Line 3560: Youth Ministry Program add a new reserve fund and transfer expense from line 219
  - Line 3110: Any 2023 unspent funds at the end of the year, transfer those funds into the Native American Ministry Reserve Account
  - Any unspent funds from Dunseith and Fort Totten would go into the Native American Ministry Reserve for future staffing

  - Whereas before we used the Matrix to monitor our goals now the New Season of Ministry Resolution passed by the Convention has set our goals for the next phase of our journey.
  - ANNOUNCEMENT: Bishop Tom has appointed Kim Fox to be our Reconciliation/Creation Care/ Congregational Development Missioner
  - Youth & Young Adult position has been published
  - Steve led the Council through the Proposal for Council Shepherding Goals from NSMTF

1. Remain one diocese with a bishop – *Standing Committee* 

- $\circ~$  Standing Committee is canonically responsible to nominate/develop the search committee for Diocesan Bishop
- 2. Develop Youth/Young Adult Ministry *Elsie Magnus, Rachel Schmidt, Jason Thoms, John Floberg* 
  - Youth Commission has two members currently: Leah Henderson & Hannah Gendron. This commission needs more members.
- 3. Develop Native American Ministry *Elaine McLaughlin, John Floberg, JoAnn Keehn, Robert Fox* 
  - NDCIM is primarily responsible
  - Beth Lipp noted that St. George's has 25% Native parishioners what more can they do?
  - Steve pointed out that this goal about native ministry across the diocese.
- 4. Develop Congregational Ministry Donna Pettit, John Baird, Elsie Magnus, Susan Lisok, Bob Hoekstra
  - Commission on Ministry and Congregational Development Committee

  - Talked about how the Episcopal Church is divided into IX provinces. We are in Province VI.
